1 Information we collect

- **Our Service & Communications**

We may collect personally identifiable information about you in case we get in touch with each other through our Service, such as your full name, phone number, email address, or similar.

- **Cookies & Tracking technologies**

We use Analytical software to track information about the visitor’s behavior on our website and agent depending on your region. This ‘automatically collected’ information may include IP address or other device address or ID, web browser and/or device type, the web pages or sites visited just before or just after visiting the website, the pages or other content the User or Visitor views or interacts with on the website, and the dates and times of the visit, access, or use of the website.

2 How we use the information

- **Our Service & Communications**
